“Whereas, said resolution conforms to the provisions of the Local Government Code of 1991;



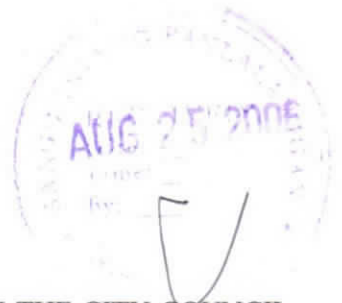

RESOLUTION NO. 376

“WHEREAS, Bayawan City is blessed with elective officials who have rendered exemplary public service worthy of emulation to all Bayawanons;

“WHEREAS, such exemplary public service shall be recognized and honored by bestowing to the concerned official a plaque of appreciation and cash gift.

“NOW, THEREFORE, on motion of Honorable Councilor Guillermo A. Diao and duly seconded by Honorable Councilor Herrero, the Council

“RESOLVED, To enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 42

AN ORDINANCE AUTHORIZING CONFERMENT OF EXEMPLARY PUBLIC SERVICE AWARD TO ELECTIVE OFFICIALS OF THE CITY OF BAYAWAN

Be it ordained that:

SECTION 1. Short Title – EXCELLENCE IN PUBLIC SERVICE.

SECTION 2. Applicability – applicable to all elective public officials who have served Bayawan from the time Bayawan was created into a Municipality.

SECTION 3. Committee on Award – the committee shall be composed of the followings:

Cl

A. Members

- 3 from the religious sector
- 3 from the NGO & Pos
- 3 from the Academe

B. The City Mayor shall appoint the members of the Committee on Award through an Executive Order.

C. The Committee members shall elect the Chairperson among themselves.

SECTION 4. Implementing Rules and Regulations –

A. Committee members shall serve only ONE (1) term consisting of Three (3) years

B. Would be awardee must have served at least One Full Term of Office.

C. In the event the would be awardee cannot attend the awarding rites, only members of his family or any relative but not to anybody not related by consanguinity.

D. In the event nobody is qualified to receive the award, said award shall be kept at the Office of the Mayor until such time said award is given to the rightful recipient.

E. The Committee shall elect an awardee by a majority vote of all the members.

F. In case of any conflict that may arise in the selection process, the City Council shall settle and decide with finality.

SECTION 5. Awards – The awardee shall receive a plaque of appreciation and a cash prize to be determined by the Committee but such amount shall not be less than TEN THOUSAND PESOS (P10,000.00). The plaque of appreciation shall be duly signed by the incumbent City Mayor and the Chairman of the Awards Committee.

SECTION 6. Frequency – The selection of the awardee shall be done once every THREE (3) years and to commence in 2007. Awarding will be during the Charter Day Celebration together with the Hamiling Bayawanon Awards. A maximum of three (3) awardees may be selected for every THREE (3) years.

SECTION 7. Effectivity – This Ordinance shall take effect after compliance with the provisions of R.A. 7160 otherwise known as the Local Code of 1991.
