
"Whereas, the aforementioned piece of legislation conforms to the provisions of the Local Government Code of 1991;

RESOLUTIONS 639

“Third and Final Reading of An Ordinance Amending Section 6 of Ordinance No. 12, s. 2014  
“Otherwise known as Ordinance Establishing a Scholarship Pprogram to Support the Poor but Deserving Students to Pursue their College Education and Appropriate Funds, Therefor.

“On motion of Honorable Councilor Renacia and duly seconded by Honorable Councilor Tizon, the Council

RESOLVED, To enact, as it hereby enacts the following ordinance:

ORDINANCE NO. 34

AN ORDINANCE AMENDING SECTION 6 OF ORDINANCE NO. 12, SERIES OF 2004  
“OTHERWISE KNOWN AS AN ORDINANCE ESTABLISHING A SCHOLARSHIP PROGRAM TO SUPPORT THE POOR BUT DESERVING STUDENTS TO PURSUE THEIR COLLEGE EDUCATION AND APPROPRIATE FUNDS THEREFORE”.

Be it ordained that:

SECTION 1. Amended provision. Section 6 of ordinance No. 12, series of 2004, “Otherwise known as an Ordinance Establishing a Scholarship Program to Support the poor but Deserving Students to Pursue their College Education and Appropriate Funds Therefore” is hereby amended and to read as follows:

“SECTION 6. This Scholarship will provide tuition cost, additional allowance of Two Thousand Five Hundred (P2,500.00) per semester and an aggregate total amount of Ten Thousand Pesos (P10,000.00) subject however, to availability of funds to pay the following, to wit:

a. Board Exam Review Fee.

b. Filing Fees with the Professional Regulation Commission (PRC)

c. Board and Lodging and travelling Allowance during filing with the Philippine Regulation Commission for one (1) day.

d. Board and Lodging, travelling allowance during Board Exam Schedule for three (3) days”


SECTION 2. Effectivity. This ordinance shall take effect and cover those Local Government Unit Scholars who have graduated last March 2015 including those who had already taken the Board Exam as of this passage on a "reimbursement basis".


