RESOLUTION NO. 651

"WHEREAS, among the provisions of the Executive Order No. 452 series 1997 of the Office of the President, specifically section 9, calls for an appropriate local ordinance creating the local council on the security of registered vendors;

"WHEREAS, the Sangguniang Panlungsod feels that it is necessary to create the local committee on the security of registered vendors.

"WHEREFORE, upon motion of Honorable Councilor Francisco T. Diao and seconded by Honorable Councilor Novelito A. Herrero, Honorable Councilor Agustin L. Barte and Honorable Councilor Antonio B. Villamil, the Council

"RESOLVES, as it hereby resolves to enact the following Ordinance:

ORDINANCE NO. 38

AN ORDINANCE CREATING THE LOCAL COUNCIL ON THE SECURITY OF REGISTERED VENDORS PURSUANT TO E.O. NO. 452 S. 1997 OF THE OFFICE OF THE PRESIDENT.

"Be it ordained that:

SECTION 1. The Local Council on the Protection of Registered Vendors for the City of Bayawan, Negros Oriental is hereby created pursuant to Executive Order No. 452 S. 1997 of the Office of the President of the Republic of the Philippines.

SECTION 2. The local council as directed under section 9(b) shall be headed by the City Administrator and shall be composed of the following, as members:

1. Chairman of the SP Committee on Market, Business or their equivalent.
2. City Planning and Development Coordinator
3. City market Administrator/Supervisor
4. Chief of City Police Office
5. At least (2) representatives of the vendors or vendors association elected from among themselves and appointed by the City Mayor. Provided that only those duly elected representatives of the vendors or vendors association shall be appointed as members of the local council.

SECTION 3. That the functions of this Local Council are those which are stipulated under Section 10 of E.O. No. 452, which among others are:

- a. Assist competent Local Authority in the formulation of plans, programs, project or activities that will ensure security of vendors in the workplace;
- b. Monitor compliance for the rules and regulations implementing E.O. No. 452;
- c. Recommend appropriate measures to the City Mayor to enhance the participation of vendors in local socio-economic development efforts;
- d. Recommend to the Inter-Agency council on the security of registered vendors, measures to improve the plight of registered vendors;
- e. Assist the conduct of survey on vacant areas for vendors; and
- f. Perform such other functions as may be provided by competent local authorities.

SECTION 4. The Local council shall hold its meeting once every quarter or as often as necessary. A simple majority of all its members shall constitute a quorum.

SECTION 5. If, for any reason or reasons, any provision of this Ordinance is declared unconstitutional or invalid, other provisions, which are not affected thereby, shall continue to be in full force and effect.


SECTION 6. This ordinance shall take effect upon compliance with the Local Government Code of 1991, R.A. 7160.


